- (c) in Form FC-7, where the foreign contribution relates to Foreign securities;
- iii) maintain a record as to the manner in which such foreign contribution has been utilised by it;
- iv) Maintain every account specified above on an yearly basis, commencing on the 1st day of January each year and every such account, duly certified by a Chartered accountant in Form FC-9 should be furnished, in duplicate to the Secretary to the Government of India, in the Ministry of Home Affairs, New Delhi, within sixty days of the closure of the Calender year.
